

- Successful Bidder shall be responsible for setting up, installation, configuration, management, upgradation, and migration of application servers, database servers/storage.
- 2) Successful Bidder will be responsible for migrating to cloud and managing the cloud services.
- 3) Successful Bidder provides inter-operability support with regard to APIs and Data Portability.
