# **Special Terms and Conditions of the contract**

# Name of Work: "ABC (Dog Sterilization) Work in Bhavnagar City"

- This work pertain to Sterilization of stray dogs of Bhavnagar City, it includes Pickup the male/female stray dogs from the Bhavnagar city limit, perform sterilization operation (overiohysteretomy/Castration), Vaccinate with anti-rabies vaccine, Kept under observation for atleast 4 days or suggested by AWBI in kennel and release them back to their respective location. (As per Animal Birth Control (Dogs) Rule-2023)
- Method of work Traditional method of ABC (Catch-Sterilize-Vaccinate-Kept under observation for post-operative care-Release at the same location from where they picked up).
- 3. The dogs shall be captured by using humane methods such as prescribed under the provisions of Prevention of Cruelty (Capture of Animals) Rules.
- 4. Dog shall be sterilized / neutered by approved method.
- 5. Veterinarian performing sterilization operation shall have registration with veterinary council of India / State council.
- Strict adherence to surgery protocol and maintenance of high level of asepsis and cleanliness must be followed as prescribed in SOP suggested by AWBI.
- 7. All the dogs brought for sterilization shall be vaccinated with Anti Rabies Vaccine manufactured by Indian Immunoligicals Ltd. or Virbac or Pfizer or Nobivac Company.
- 8. Bhavnagar Municipal Corporation will provide Police or security protection in sensitive areas during dog catching.
- Agency shall have to make arrangement for worker and doctors required for sterilization work.
- 10. Agency shall follow the Animal birth Control (dogs) rules, 2023 and subsequent amendment to it and the Supreme Court guidelines. Any breech in implementing this rules agency shall be liable for that.
- 11. Minimum 2000 Dogs shall be sterilized every Quarterly during first year. During earlier quarter, if more number of dogs shall be sterilized, than that more number of sterilized dogs shall be counted in target of sub-sequent quarter for penalty.
- 12. In case of agency fails to perform stipulated number of dog sterilization operation, penalty of Rs. 100/- per less dog operation will be charged and will be deducted from the bill.
- 13. If any dog brought for ABC or post ABC needs treatment, it shall be given by <sup>agency at</sup> their cost.

- 14. Bhavnagar Municipal Corporation shall provide place for clinic, Dog Kenal and facility for electricity (electricbill will be supposed to pay by agency) & water supply needed for dog sterilization work. Other all facilities i.e. Vehicles, Dog Catching equipments, Dog Sterilization Equipments, Instruments, Medicines, Requirements of Post-operative care of Kamel dog, Accommodation facility (Except ABC Centre), employees etc. shall be of agency or borne by agency.
- 15. Bhavnagar Municipal Corporation officer will visit operation site and field work at any time and can inspect the work and records.
- 16. Daily work report shall be furnished to Bhavnagar Municipal Corporation.
- 17. All the expenditure pertaining to sterilization work shall be borne by agency.
- 18. Bhavnagar Municipal Corporation will issue identity card to person working with sterilization project if required by the agency.
- 19. All the sterilized dogs shall be marked with 'V' notch mostly on left ear for identification.
- 20. A records of dogs captured shall be maintained in register, mentioning therein the name of the area/locality, date and time of capture, names of persons in the dogs squad on that particular day, detail of vehicle and details about dogs captured such as number of male dogs, number of female dogs, number of puppies etc., date and number of dog sterilization, dogs kept in kennel under observation and date and time of release.
- 21. Agency shall have trained staff for sterilization work.
- 22. The working hours for the work shall be as per suggested by BMC officials.
- 23. Daily supervision of this work by the agency or his authorized representative is necessary, so that any complain can be immediately solved.
- 24. The payment for this work shall be made after the submission of bill. The agency shall have to submit a certificate of "work has done in accordance with the terms & conditions of the contract" along with the Bill.
- 25. Bio-Medical waste shall be disposed off as per the prevailing rules and regulations.
- 26. Agency shall strictly follow and abide by all guidelines outlined in the "Standard Operating Procedures" for Sterilization of Stray Dogs under the Animal Birth Control Program, compiled by Animal Welfare Board of India.
- 27. Agency shall strictly follow dog sterilization work as per given by the BMC officers.
- 28. Complains of Rabid dog shall have to be attend & Solve by agency immediately. No any extra payment shall be paid for that.
- 29. No sterilized dog/s shall be caught for Sterilization, if by chance any sterilized dog caught, it must be released at the site before loading into vehicle for transportation.
- 30. Agency has to work as per instruction of BMC. i.e. Ward to ward dog sterilization, Zone wise dog sterilization, area wise dog sterilization etc and agency has to strictly follow them to achieve result.

- 31. If AWBI makes change in period of post operative care of dogs (Increase/Decrease days of post-operative care), it shall be applicable to agency and agency has to work accordingly. If, AWBI approves CNVR (Catch-Neuter-Vaccinate-Release of dogs on same day) method, agency has to work by CNVR method. Amount of post-operative care of per dog per day shall be deducted/added from/on the rate (rate of traditional method of ABC, which includes post-operative care for 3 days) approved by BMC and shall be applicable to agency. Therefore, cost of post-operative care of per dog per day is mentioned extra, separately in price schedule.
- No payment shall be paid of Dog died during sterilization work; work includes still release of dogs.
- 33. Agency shall have to maintain all registers and record as per Animal Birth Control (Dogs) Rules-2023.
- 34. Agency shall have to destroy organs after inspection by organs inspection committee as per Animal Birth Control (Dogs) Rules-2023 Guideline.

# Name of Work: "ARV (Anti-Rabies Vaccination) Work in Bhavnagar City"

- This work pertain to Anti-Rabies Vaccination of stray dogs of Bhavnagar City, it includes Pickup the male/female sterilized & adult stray dogs only from the Bhavnagar city limit, 1. Vaccinate with anti-rabies vaccine, mark with colour coding to vaccinated dog and release them back at spot to their respective location
- Method of work Vaccinate male/female sterilized & adult stray dogs strictly by society/area/ward wise to cover most population of dog under ARV to achieve result. 2.
- The dogs shall be captured by using humane methods such as prescribed under the 3. provisions of Prevention of Cruelty (Capture of Animals) Rules.
- Dog shall be vaccinated by approved method of S/c or I/m. 4.
- Veterinarian performing vaccination shall have registration with veterinary council of India / State council or Any Authorized person performing vaccination shall have legally 5. approval or approval of AWBI for vaccination.
- Strict adherence to vaccination and maintenance of high level of asepsis must be 6.
- All the dogs shall be vaccinated with Anti Rabies Vaccine manufactured by Indian 7. Immunologicals Ltd. or Virbac or Pfizer or Nobivac Company.
- Agency shall have to make arrangement for Vehicle, Driver, Workers and Doctor 8. required for ARV work.
- When started ARV (After instruction of BMC Officials), Minimum 2000 Dogs shall be vaccinated every month. During earlier month, if more number of dogs shall be 9. vaccinated, than that more number of vaccinated dogs shall be counted in target of subsequent month for penalty.
- In case of agency fails to perform stipulated number of dog vaccination, penalty of Rs.50/- per less dog vaccination will be charged and will be deducted from the bill. 10.
- Work of ARV shall be of 2 phases. 1<sup>St</sup> Phase of ARV shall be started along with starting of ABC work and cover dogs of all city area as earliest. 2<sup>nd</sup> Phase of ARV (Annual Re-11. vaccination) shall be started after completion of 1st year of starting of ARV or as per instruction given by BMC officials. (Annual revaccination of ARV)
- If any dog shows pathological symptom, after giving ARV, necessary treatment shall be 12. given by agency at their cost.

- Daily supervision of this work by the agency or his authorized representative is 22. necessary.
- The payment for this work shall be made after the submission of bill. The agency shall have to submit a certificate of "work has done in accordance with the terms & 23. conditions of the contract" along with the Bill.
- Bio-Medical waste shall be disposed off as per the prevailing rules and regulations. 24.
- ARV shall not be given to unsterilized dog/s, unsterilized dog/s shall be sent for ABC 25.
- ARV shall not be given to any puppy, ARV shall be given to only sterilized adult dogs or as per BMC instruction. Agency has to work as per instruction of BMC. i.e. Ward to ward, 26. Area to area & Society to Society wise ARV work and agency has to strictly follow them
- No payment shall be paid of ARV given to owner's Dog/Puppy/Un-sterilized dog. If ARV is given in that case/s, no payment shall be paid of that ARV work. 27.
