<b>Site Situation at present</b>	<p>The river is locally known as Gadhechi / Gadhechi river / Gadhechi nala. This Gadhechi river is passing through city area and is downstream of city lake known as Gaurishankar lake. Both side of this river encroached by local resident ( mafatnagar). This river is polluted by resident of river bank so dirty water is flowing in the river. Encroachment shall be demolished by BMC authority as per requirement of project ROW width. Both side sewer line proposed so all the sewage outlet can be trapped. Aims of project is to river make pollution free and aesthetic look of river. <b>It is advised to visit the site before bidding the tender.</b></p>

OR</li> <li>(2a) Two similar completed works, each costing not less than amount equal to 50% of the Estimated Cost. OR</li> <li>(3a) One similar completed works, each costing not less than amount equal to 80% of the Estimated Cost</li> </ol> <p><b>Similar work means Canal Lining Project / River Rejuvenation Project /River front Development Project.</b></p> </li> <li>(b) Turnover during last 3 years, ending 31st March of previous financial year, should be at least 30% of Estimated Cost. An attested copy of annual turnover for last 3 years should be enclosed.</li> </ol>

(c) List of the works already completed in last 7 years and attested copies of certificates from head of the office concerned for completion of the works.
