General Terms & Conditions

of tender for Supply of Underground Sewer Cleaning Rod of 7mm Dia and 1200mm in length, spring steel material (IS-4454 P.T.I GRADE - II) with end coupling at Bhavnagar Municipal corporation .

1. The tenders received after due date (i.e. 21/04/2025), or without Earnest Money Deposit (EMD) and tender fee, or with incomplete details will be rejected.
2. The tenderer will have to submit **EMD of Rs.13611/-** and **tender fee Rs.1500/-** with tender in the form of Demand Draft (DD) in favour of commissioner shree, Municipal corporation Bhavnagar. The tenders received Without EMD are liable for rejection. (If the EMD is in the form of D.D. than it should be signed on stipulated form by tenderer affixing revenue stamp of Rs. 1/- and have to be supplied along with bid.).
3. The EMD submitted by the bidder will be forfeited under the following circumstances:
 - a. Failure to Submit Security Deposit: If the bidder fails to submit the required security deposit within 10 days from the date of issuance of the LOI.
 - b. Failure to Sign Legal Agreement: If the bidder fails to enter into a legal agreement on a ₹300 stamp paper within 10 days from the date of issuance of the LOI.
4. The tenderer is required to submit their tender/bid in a sealed envelope, which must include the following details: the name of the tender, the name of the company, the company's address, and contact details. The tender/bid should be sent via Registered Post Acknowledgment Due (Regd. Post AD) or Speed Post to the following address:

The tender must reach the above address by the specified due date. Any tenders/bids received after the last date of submission, as mentioned in the advertisement, will be rejected without any further notice.
5. Payment will be made in accordance with the regulations of Bhavnagar Municipal Corporation (BMC). No advance payment will be allowed.
6. The successful tenderer shall submit a Security Deposit equivalent to 5% of the contract amount in the form of a Demand Draft (DD), Bank Guarantee (excluding State Bank of India), or a cash payment receipt obtained from BMC, within 10 days from the date of the Letter of Intent (LOI). Please note, no interest will be paid on the Security Deposit.
7. The rates quoted by the tenderer shall be inclusive of excise duty, state and central GST, material testing charges, transportation charges, transit insurance, packing and

forwarding charges and other all levies and duties chargeable and applicable at the time of delivery. No additional charges shall be payable besides the rates approved by BMC.

8. The successful bidder shall be required to enter into a legal agreement on a 300 INR stamp paper, as per applicable rules, at their own risk and cost, within 10 days of receiving the Letter of Intent (LOI).
9. All tender documents must be verified by the tenderer through the signature and seal of the company. The tenderer may be required to submit the original documents during the evaluation process if requested by this office. Failure to provide validation of the submitted documents will result in the rejection of the tender, without any further notification.
10. The rates offered by tenderer will be valid for 12 months from issuing the work order. The successful bidder shall have to supply goods at approved rates for aforesaid period on as and when basis as per the demand of Bhavnagar municipal corporation & Rate increase will not be given in any circumstances.

11. PRICE BID:

- a. The time and date for opening of the Price Bid shall be determined by the Corporation and shall be communicated to the tendering firms after technical bids are analyzed and the intimation will be sent only to the technically qualified tenderers.
- b. Rate should be quoted both in clear figures and words in provided price bid format along with signature of contractor and seal of company.
- c. Bidders must submit all pre-qualification and technical bid documents in one sealed envelope, and the price bid tender in a separate sealed envelope. Each envelope should be clearly marked as 'Technical Bid Tender Cover' and 'Price Bid Tender Cover,' respectively. Failure to adhere to this requirement will result in the rejection of the tender.

12. TECHNICAL SPECIFICATIONS:

For Item Sr. No. 1 Party shall have to supply the:

Sewer cleaning rods with suitable designed end couplings, 1.2 mtr. Length and 7.0 mm diameter as per following specification:

1. Material should be spring steel and confirm to IS-4454 P.T.I GRADE – II.
2. The rods shall be bent at an angle of 90° at radius 625 mm and torque of 26 Kg - mtr. Is applied for 5 hours. The rod should retain elasticity and should not show any sign of crack or change of shape after the test. -Ultimate tensile strength – 140 Kg. / CM² as per IS1521 of 92.
3. Material testing certificate as per above IS specifications from Govt. approved institute should be issued with delivery of goods.
4. End – couplings should be of proper design for of 100 mtrs. Designs of End - couplings should be as per I.S. Standards.
5. Outer surface of the rods must be galvanized to prevent the corrosion.

13. Any dispute arising out of the contract shall be subject to Bhavnagar Jurisdiction only.
14. Party shall have carry out material inspection as per IS specifications mentioned in price bid form Sr. No. (i) And other test as per I.S. specifications of sewer cleaning rod as mentioned in price bid form Sr. No. (ii) From any Govt. approved laboratory. Party shall have to provide the confirming test certificates to BMC complying I.S. specifications mentioned as above before supplying the goods at supplier's own cost.
15. Bhavnagar Municipal Corporation reserves the right to accept/reject/Cancel any or all the offers/tenders, extend dates and / or re-advertise tender, and /or modify the process at any stage of the process without assigning any reason thereof.
16. Offered tender bid should not be conditional if there are any deviation apart from terms & condition mentioned in tender then tenderer should have to clearly mentioned that in offer bid.
17. Tenders received in prescribed tender forms with duly signed by supplier shall abide to these terms & conditions. Price & details offered on tenderer's own letter head shall be rejected.
18. Party shall have to provide the Proof for the successfully executed past purchase orders of Sewer Cleaning Rods to any government, semi-government, government undertakings, reputed Private firms or corporations along with bid for our ready references.
19. **PENALTY CLAUSE :**
 - a. On approval of the tender the tenderer should arrange to supply demanded ordered quality of each item within the time limit stipulated in supply order. In case the tenderer fails to supply the same within the time-limit stipulated in supply order, penalty will be charged at the rate of 0.01% per day of the ordered value.
 - b. If the successful tenderer fails to supply the ordered goods as per specifications and quality within stipulated period, the Corporation shall have right to procure the same from the other agencies as deemed fit (i.e. without giving any further notice at supplier's risk, cost and consequences.) The extra cost thus imposed shall be recovered from the successful tenderer and the decision of Municipal Commissioner shall be final, conclusive and binding to the tenderer.
 - c. If the supplied goods / materials are not found confirming to the specifications, the same will be rejected and supplier will have to replace the material with in 15days on party's risk and cost basis.
 - d. If the specification of supplied goods / materials are not found satisfactory, the security deposit of supplier will be forfeited and contract will also be terminated without giving any notice thereof.
20. BMC reserves right to increase or decrease the ordered quantity by 25%.

21. The BMC reserves the right to accept the tender in favor of different tenderer on item wise basis either in full or part or reject all the tenders without assigning any reason thereof.
22. The tenderer will have to provide the guarantee/warranty certificate along with supply if applicable.
23. The tenderer will have to provide the PAN card and GST certificate along with bid.
24. The tenderer will have to provide the professional tax certificate (F.Y:2023-24) along with bid.
25. Bidders should enclose last three financial year (2021-22, 2022-23, 2023-24) income tax return copies with technical bid documents.
26. **DELIVERY CLAUSE:**
 - a. The delivery period will be **1week from the date of Dispatch instruction (DI)**.
 - b. The rates offered by tenderer will be **valid for 12 months from issuing the supply order**. The successful bidder shall have to supply goods at approved rates for aforesaid period on as and when requirement basis as per the demand of Bhavnagar municipal corporation & Rate increase will not be given in any circumstances.
 - c. The party shall be required to supply the materials in properly packed condition to the **Drainage Department's Store at BMC**. The party shall also be responsible for ensuring the safe delivery of the materials to the designated location.
