- Tenderer shall be required to submit the enlisted documents in hard copy along with the Qualification Bid. If documents are insufficient or it does not match the required criteria mentioned below, then the Price Bid of the tenderer shall not be opened.
- Mainly tenderer shall fulfill following Technical & Financial pre-qualification criteria as a main contractor. The tenderer shall fulfil the following all points **A to N** requirements / experiences for qualification.
 - A. The Bidder must have achieved **average annual turnover** during last three financial years, ending on 31st March 2025 of **Rs.14.90 Lacs**.
 - B. The Bidder shall have experience in Lowering , Laying and Jointing of DI line, JOB Work or similar work as per this tender item.
 - One work of similar nature with 80% of Estimated cost
or
 - Two works of similar nature 50% of Estimated cost
or
 - Three works of similar nature 40% of Estimated cost
 - D. An attested copy of registration with MES, various departments of State Government, Municipal Corporations, CPWD etc. Registration required:“**E-1” class**”.
 - E. The experience of Joint Venture / Back to back work/ Nominated Sub-contractors by agencies shall not be considered.
 - F. The Bidder should submit **Solvency Certificate** minimum value of **Rs. 9.93 lacs** issued by schedule bank / Nationalized bank only and should be valid for at least up to six months from the date of submission.(Considering validity as 1 year from date of issue of Solvency Certificate)
 - G. The Bidder should submit the list of the works already completed during last 5 year in prescribed Performa and attested copies of certificates issued by head of the office concerned for completed work.
 - H. The Bidder shall submit Declaration regarding the work on hand with the bidder in prescribed Performa. Attested copies of work orders, interim certificate if any shall also be attach as supporting documents for above.
 - I. Joint Venture shall not be allowed.**

 - (1) Will reject a proposal for award if it determines that the bidder has engaged in any corrupt or fraudulent practices in competing for this contract or in past history and
 - (2) Will reject a proposal if it found debarred/blacklisted by any State Govt. /Govt. of India/ Semi Government/ PSU in last 10 years.
